Pursuant to O.A.C. 4901-1-13(A), the Staff of the Public Utilities Commission of Ohio (Staff) respectfully requests a continuance of the September 27, 2012 testimony filing deadline and continuance of the October 9, 2012 hearing date. Staff requests that the extension of the testimony deadline apply to all Intervenors as well as Staff. Staff also requests that the Commission issue an expedited ruling on this motion pursuant to O.A.C. 4901-1-12(C). Staff requests that the Commission modify the procedural schedule as follows:

- Hearing – **Tuesday, October 16, 2012**




