Dear Sir or Madam:

Enclosed on behalf of Ormet Primary Aluminum Corporation ("Ormet") please find Ormet's Schedule A for 2013, as permitted under section 5.03 to the power agreement between Ormet and Columbus Southern Power Company and Ohio Power Company (collectively "AEP Ohio") submitted in Case No. 09-119-EL-AEC.

The Power Agreement between Ormet and AEP Ohio allows Ormet to submit a revised Schedule A by October 1, 2012 for calendar year 2013. Schedule A contains a Target LME of \$2,805 per metric tonne, as compared to the 2012 Target LME of \$2,754 per metric tonne. The increase of \$51 per metric tonne is due to the increase in the cost of electricity from \$51.17/MWh to \$57.23/MWh. The \$57.23/MWh figure is based on AEP's 2012 Fourth Quarter FAC Filing and AEP's forecast of the 2013 Ohio Tariff Rate. If the Ohio Tariff Rate changes, Ormet may file an amended schedule pursuant to Section 5.03 of the Power Agreement. If the rate would have been \$51.17/MWh as originally forecasted for 2012, the target LME for 2013 would have been \$2,719 per metric tonne, or a reduction of \$35 per metric tonne. Ormet anticipates operating four pot lines from January through April, five pot lines in May and six potlines for the balance of 2013 if the continuous improvement in aluminum market prices during the year we have forecasted occurs. Very recent LME prices for aluminum, as indicated by the forward curve, are less optimistic than the forecasters' projections, but it is currently Ormet's plan, assuming that the prices continue to rise, to increase the operating level at the Hannibal plant during the year.

**ORMET ALUMINUM
ELECTRICITY RATES
For the Calendar Year 2013**

LME PRICE (If the LME Price (\$/tonne) is)	ORMET RATE (Then Ormet shall pay (\$/MWh))
Less than the Target LME Price	AEP Ohio Tariff Rate minus \$0.0709378/MWh for each \$1/tonne less than the Target LME Price
Target LME Price = \$2,805	AEP Ohio Tariff Rate = \$57.23/MWh
Greater than the Target LME Price but not more than \$300 above the Target LME Price	AEP Ohio Tariff Rate plus 4% = \$59.52
Greater than \$300 above the Target LME Price	AEP Ohio Tariff Rate plus 8% = 61.81

NOTES:

1. The AEP Ohio Tariff Rate reflects the amount Ormet would pay based on a 98.5% load factor if 50% of its load were billed based on the Ohio Power Company Schedule GS-4 Transmission Bundled Service and 50% of its load were billed based on the Columbus Southern Power Company Schedule GS-4 Bundled Service delivered to Ormet.
2. In the event that the AEP Ohio Tariff is modified prior to or during 2013, this schedule shall be modified as follows to reflect a new Target LME Price consistent with the revised AEP Ohio Tariff Rate:

$$TP_1 = TP_0 + (TR_1 - TR_0) / 0.0709378$$

Where:

TP_1 = Revised Target Price

TP_0 = 2013 Target LME Price (i.e., \$2,805/tonne)

TR_1 = Revised AEP Ohio Tariff Rate based on a 98.5% load factor

TR_0 = Anticipated 2013 AEP Ohio Tariff Rate based on a 98.5% load factor
(i.e., \$57.23/MWh)
