By letter issued October 1, 2012, the Public Utilities Commission of Ohio issued a letter canceling Certificate Number 90-5352. It has come to our attention that the wrong certificate was canceled. By this letter, the Commission wishes to inform you that Certificate Number 90-5352 has been reinstated and Certificate Numbers 90-5304 and 90-5329 have been canceled as a result of Case No. 11-4397-TP-RCC. As a result of the cancellation of Certificate Numbers 90-5304 and 90-5329, New Cingular Wireless PCS, LLC is no longer authorized to provide public utility service under those certificates in the State of Ohio. 
