Pursuant to Ohio Adm. Code Rule 4901-1-21(B), please take notice that The Dayton Power and Light Company ("DP&L") will take the oral deposition of the following individual:

The deposition will take place beginning on October 17, 2012, following the depositions that have previously been scheduled through mutual agreement between DP&L and the Office of Ohio Consumers' Counsel ("OCC") for OCC to depose witnesses for DP&L who have submitted testimony in this proceeding. The deposition will be at the offices of the Ohio Consumers' Counsel, 10 W. Broad St., 18th Floor, Columbus, Ohio 43215, or as otherwise agreed to.

Other parties to the proceeding are invited to attend and cross-examine.

The depositions will be taken of the aforementioned deponent on relevant topics within deponent's expertise as it pertains to the 2011 Management/Performance and Financial Audits of the Fuel and Purchased Power Rider of DP&L and his pre-filed testimony in this proceeding.

DP&L had no knowledge of the scope of Mr. Sloan's testimony or whether depositions would be warranted, until Mr. Sloan filed pre-filed testimony on October 4, 2012, which was delayed three days pursuant to a motion filed by OCC on the day testimony was originally scheduled to be filed, October 1. Subsequently, the evidentiary hearing date was extended to November 5, 2012 and, thus, this notice is being given at a reasonable time in advance of the hearing. The date for the deposition has been coordinated with the mutually agreed upon date for depositions by the OCC of DP&L witnesses so as to minimize any inconvenience of witnesses, parties or attorneys.


