JOINT MOTION OF AMERICAN BROADBAND AND TELECOMMUNICATIONS COMPANY AND FRONTIER NORTH, INC. FOR A STAY OF PROCEEDING

On April 19, 2010 American Broadband and Telecommunications Company ("American Broadband") filed a complaint against Frontier North, Inc. "(Frontier" f/k/a Verizon North). American Broadband filed its Motion for Leave to File an Amended Complaint on September 10, 2012. This Motion was granted by Attorney Examiner Entry on October 12, 2012. The Entry also directed Frontier to file its answer by October 29, 2012.
