REVISED NOTICE OF DEPOSITIONS

Pursuant to Rule 4906-7-07(E) of the Ohio Administrative Code, Champaign Wind LLC gives notice to all parties and to the Ohio Power Siting Board of its intention to take the deposition of witnesses upon oral examination who will be sponsoring testimony or testifying on behalf of the intervening parties in this proceeding in Case No. 12-0160-EL-BGN and of Robert McConnell.
