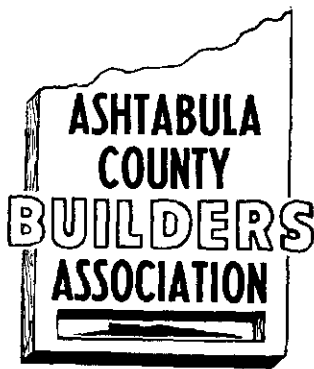
I would request that the letter of support be docketed in the official record of ASHTA's application referenced above.

The Ashtabula County Builders Assoc. has many varied types of members in its roles and many of our members have direct involvement with ASHTA. But more importantly to our membership is the involvement that our members have with the employees of ASHTA Chemicals. ASHTA Chemicals employees over one hundred people with an annual payroll of more than \$8 million dollars.
