EMS crews from the Allen Center base respond into Champaign County to transport patients from car crashes and other emergencies. While the Champaign Countywide 911 Dispatch Center logs EMS calls for service, MedFlight keeps its own detailed records and procedures. As this information is pertinent to the concerns over siting wind turbines within northeast Champaign County townships, it is relevant to the Champaign Wind proceeding and may be useful in developing certificate conditions to address safety issues. For the foregoing reasons, the City of Urbana, Ohio, requests the Administrative Law Judge issue the attached subpoena.
