# Description and Rationale for Proposed Change and Customer Notice

Cincinnati Bell Inc. (CBI) merged Cincinnati Bell Telecommunications Services LLC (CBTS), a CBI subsidiary, into Cincinnati Bell Telephone Company LLC (CBT), a separate CBI subsidiary. CBT is an Incumbent Local Exchange Carrier providing service in Ohio with TRF No. 90-5013. CBTS provided payphone services in Ohio, including AOS services, which were provided under Certificate No. 90-5859. With the merger of CBTS into CBT, CBT is filing to transfer the CBTS certificate to CBT. Furthermore, the certificate should be cancelled once it is transferred because it duplicates CBT's current authorization to provide service. This filing is in the public interest because it supports continued provision of payphone and AOS services within Ohio.

CBTS marketed its AOS services using the name "Cincinnati Bell." CBT will continue to market these services under the "Cincinnati Bell" name, so this change will be transparent to the AOS users. Furthermore, no rates, regulations, or services will change as a result of this filing. No customer notice is being provided because of the transient nature of payphone customers and because no changes will be apparent to users of the AOS services.
