This comment is in reference to Case 12-1682-EL-AIR, the proposal by Duke Energy to allow Cincinnati City Council to add a surcharge for the Cincinnati Streetcar.

I live outside the city of Cincinnati and would never expect to be footing the bill for a public service that is not in my home city, especially when this "service" is a money pit. I and my wife are seniors on fixed incomes struggling already to keep up with ever-increasing costs of staples and services. We don't need or want to be paying for anything that has to do with the Cincinnati streetcar project.

We have followed the streetcar project carefully over the past few years. The City of Cincinnati is trying to make Duke pay part/all of the cost of relocating electric lines to make room for the streetcar. It is not clear whether Duke has agreed to this "extortion". We suggest that Duke settle upfront with Cincinnati rather than using the backdoor (application to PUCO) to avoid responsibility for any possible "streetcar assessment".

Please do not approve their request. It would be a bad precedent and would adversely impact many who are least able to afford such a "tax".
