COMMENT DESCRIPTION:

I am a citizen of Champaign County and am very opposed to the turbine initiative. The setbacks are not far enough for safety or nuisance purposes. This is being lobbied by a big corporation at the expense of home values and quality of life to the citizens that it is supposed to benefit. I also find it very disconcerting that Everpower is using out-of-county and out-of-state people to support the turbines with form letters. As such, those should be discounted compared to residents who actually live here and will have to deal with the negatives or positives of living with the project (nuisances, noise, health issue, reduced property value, etc.) At a minimum, if this is allowed to proceed, Everpower should be required to make property value guarrantees to all homeowners within 1 mile of a turbine. I am also very disturbed by Everpower's portrayal of industrial wind turbines having absolutely no negative consequences, so that citizens can actually make a fully informed decision. As my mother always says, if it's too good to be true, it usually isn't.

I am not anti-wind power. I am not against renewable energy. I just believe that they should be the result of initiatives at the local level for homeowners, not for a large corporation that is sacrificing and degrading an entire community for its bottom-line profit.
