Extended Area Service (EAS) provides measured rate extended area local calling to the exchanges that are designated as Extended Area Service below. EAS is automatically provided on all voice services.

EAS is available on operator assisted calls. The usage charges applicable to the calling number, not the billed number, apply. Operator Assisted service charges as specified in this tariff also apply. Busy Verification and Interrupt Service charges specified in this tariff also apply to EAS.

The local directory assistance service regulations and rates specified in this tariff will apply for requests for telephone numbers within the EAS service areas.
