Thank you for contacting the Ohio Power Siting Board (OPSB) regarding Oregon Clean Energy, LLC's proposed Electric Generation Facility in Oregon, Ohio. Your correspondence concerning the project has been docketed in case number 12-2959-EL-BGN.

On November 13, 2012, Oregon Clean Energy, LLC filed a pre-application notification letter to the OPSB and subsequently scheduled a public information meeting for the proposed facility. That meeting was held on November 29, 2012 in Oregon, Ohio. In addition to the company representatives, several OPSB staff members were in attendance.

To date, the OPSB has not received an application from Oregon Clean Energy, LLC concerning this project. In the pre-application notification letter, the applicant describes the project as a combined cycle natural gas fired facility utilizing combustion turbines and heat recovery steam generators. Once an application is filed, the OPSB staff will begin their work, first reviewing the application for completeness and then conducting a staff investigation. I have attached an OPSB flowchart for your reference.

Once filed, the application will be available online at www.OPSB.ohio.gov. The case number for this project is 12-2959-EL-BGN.
