APPLICATION OF FIBERNET OF OHIO, LLC TO WITHDRAW THE PROVISION OF TELECOMMUNICATIONS SERVICES IN THE ATHENS, GALLIPOLIS, PORTSMOUTH, SOUTH POINT AND STEUBENVILLE, OHIO EXCHANGE AREAS

FiberNet of Ohio, LLC, ("FiberNet" or "Applicant"), through its attorney, hereby respectfully requests that the Public Utilities Commission of Ohio ("PUCO") grant this Application to withdraw the provision of local exchange and interexchange telecommunications services in the local exchange areas of Athens, Gallipolis, Portsmouth, South Point, and Steubenville, Ohio effective February 25, 2013. In support of said Application, FiberNet represents the following:

- 2. FiberNet of Ohio, LLC ("FiberNet"), is a facilities-based CLEC authorized by the PUCO to provide competitive telecommunications services in select markets within the current AT&T and Frontier North ILEC service areas in Ohio through PUCO Certificate No. 90-9201.
- 3. FiberNet was recently a party to two regulatory proceedings before the PUCO. In Case No. 10-1063-TP-ACO, the PUCO authorized a change in control of FiberNet from One Communications Corporation to NTELOS Holdings ("NTELOS").
- 4. Thereafter, in Case No. 11-2324-TA-ACO, the PUCO approved a plan proposed by NTELOS to create separate wireless and wireline businesses by spinning off the wireline business into a separate, publicly traded company. This particular transaction was finalized on or about November 1, 2011, and as a result, the corporate wireline business unit, which includes FiberNet of Ohio, LLC, was rebranded as Lumos Networks.
- 5. Although the corporate wireline business unit was rebranded as Lumos Networks, the corporate name of FiberNet of Ohio, LLC has not yet been changed, and as a result, FiberNet continues to operate as a CLEC in Ohio under its certificated name: FiberNet of Ohio, LLC.
- 6. For strategic, business and economic reasons, FiberNet desires to withdraw its continued provision of local and interexchange telecommunications services to current customers in the Athens, Gallipolis, Portsmouth, South Point and Steubenville, Ohio exchange areas effective February 25, 2013, and to thereafter close its collocation arrangements in the aforementioned central offices. Athens and Portsmouth are located in the current Frontier North service territory in Ohio, while Gallipolis, South Point and Steubenville are located in the AT&T service territory in Ohio.
- 7. As of the time of this filing, FiberNet has 38 business customers with a total of 239 access lines in the Athens exchange, 69 business customers with a total of 255 access lines in the Gallipolis exchange, 28 business customers with a total of 514 access lines in the Portsmouth exchange, 28 business customers with a total of 79 access lines in the South Point exchange, and 22 business customers with a total of 47 access lines in the Steubenville exchange.
- 8. It is FiberNet's intention to give affected customers located in the aforementioned local exchange areas written notification via direct mail and a period of at least forty-five (45) days in which to either disconnect or migrate service without penalty to an alternative telecommunications service provider. A copy of the customer notification letter, which is scheduled to be mailed out to affected customers on or about January 8, 2013, is attached hereto as Exhibit A.

- 9. FiberNet will return any deposits previously collected from the affected customers by on or before March 31, 2013.
- 10. At present, FiberNet is assigned the 740-566-1000-1999 number block in the Athens exchange area, the 740-578-8000-8999 number block in the Gallipolis exchange area, the 740-529-6000-6999 number block in the Portsmouth exchange area, and the 740-278-4000-4999 number block in the Steubenville exchange area. FiberNet does not have a number block assigned for its use in the South Point exchange area. South Point is not an individual rate center and is instead considered part of the Ironton, Ohio rate center. Upon the orderly migration of its customers and the subsequent closure of the collocation arrangements for which a number block has been obtained, FiberNet will timely return the above-referenced number blocks back to the North American Numbering Plan pooling administrator.
- 11. Despite its instant request to withdraw the provision of telecommunications services in these local exchange areas, FiberNet will continue to provide competitive telecommunications services to its remaining customers presently located in the State of Ohio in accordance with PUCO Certificate No. 90-9201.
- 12. Since FiberNet is only requesting to withdraw the continued provision of telecommunications service to current customers in the designated local exchange areas of Athens, Gallipolis, Portsmouth, South Point and Steubenville, Ohio, and will continue to provide competitive telecommunications service to its remaining customers in Ohio, no changes or other modifications to its formal tariffs in Ohio are necessary at this time.

WHEREFORE, for all of the reasons herein stated, FiberNet of Ohio, LLC respectfully requests that the Public Utilities Commission of Ohio grant its Application to withdraw the provision of telecommunications services to customers located in the Athens, Gallipolis, Portsmouth, South Point and Steubenville, Ohio local exchange areas effective February 25, 2013, along with such other relief as the PUCO may deem just and proper.
