## **ENTRY**

## The Commission finds:

- (1) The Applicants, Sandelwood Water LLC (Sandelwood) and Fairlane Water Company, Inc. (Fairlane), are public utilities as defined in Section 4905.02, Revised Code, and, as such, are subject to the jurisdiction of this Commission.
- (2) On July 5, 2011 and July 27, 2011, respectively, Sandelwood and Fairlane filed applications to amend their respective tariffs to bring their tariffs into compliance with Rule 4901:1-15, Ohio Administrative Code (O.A.C.).
- (3) On November 29, 2012 and November 30, 2012, respectively, Fairlane and Sandelwood docketed amendments to their notification of customer rights, and for Fairlane its bill format, to reflect changes to the contact information for the Commission and for The Office of the Ohio Consumers' Counsel adopted in Case No. 11-4910-AU-ORD.
- (4) The Commission has reviewed the applications filed by Sandelwood and Fairlane seeking to amend their tariffs, notifications of customer rights and bill format and the Commission finds the revised filings do not appear to be unjust or unreasonable and are not for an increase in any rate. Therefore, we determine that the applications should be granted.

It is, therefore,

ORDERED, That the applications filed by Sandelwood Water LLC, and Fairlane Water Company, Inc. are approved and Sandelwood and Fairlane are authorized to file in final form four complete, printed copies of tariffs sheets consistent with this Entry. Sandelwood and Fairlane shall file one copy in their respective TRF Docket No. 89-7030-WW-TRF and TRF Docket No. 89-7010-WW-TRF (or may make such filing

electronically as directed in Case No. 06-900-AU-WVR), and one copy in the respective case docket. The remaining two copies shall be designated for distribution to the Rates Division of the Commission's Utilities Department. It is, further,

ORDERED, That the effective date of the new tariffs shall be a date not earlier than both the date of this Entry and the date upon which four complete, printed copies of each applicants' final tariffs are filed with the Commission. It is, further,

ORDERED, That nothing in this Entry shall be deemed to be binding upon this Commission in any subsequent investigation or proceeding involving the justness or reasonableness of any rate, charge, rule or regulation. It is, further,

ORDERED, That a copy of this Finding and Order be served upon Sandelwood Water LLC and Fairlane Water Company, Inc.
