This move by PUCO undermines future potential investment by the solar-PV industry. The project's investors have secured investments, and allocated funds; the request submitted to Ohio PUCO on 7/1/11 that would allow AEP to collect \$180M towards this project from ratepayers was not voted on until last week - on the surface, this seems unconscionable, and were I a potential investor looking at the PV-solar industry in Ohio, I would have a hard time with this recent development. The project was moving, and the 18 month lag between Turning Point/AEP's filing with PUCO and their decision means that loans taken out will need to be paid back, potentially at a loss to the business. One look might be all I need to shift my attention elsewhere.

Please consider the courses of action available to you. AEP is willing to invest tens of millions of their dollars. Please allow them to collect the capital they need to let this industry grow here in the state I love calling home.
