ENTRY

The Attorney Examiner finds:

- (1) By entry issued November 27, 2012, the hearing in this matter was scheduled to commence immediately after another proceeding filed by the complainant, Gwendolyn Tandy, on January 15, 2013. However, due to Ms. Tandy's limited availability on January 15, 2013, the hearing on this complaint was not held.
- (2) By entry issued January 23, 2013, the hearing was rescheduled for February 6, 2013, 11:30 a.m., at the offices of the Commission.
- (3) Ms. Tandy did not contact the Attorney Examiner prior to the hearing nor appear for the hearing. Subsequently, Ms. Tandy contacted the Attorney Examiner claiming that she was unaware of the hearing date and stating that she had a death in the family.
- (4) Accordingly, the Attorney Examiner again finds it necessary to reschedule the hearing in this matter. The hearing shall be rescheduled for Thursday, February 28, 2013, 11:30 a.m., at the offices of the Commission, 180 East Broad Street, 11th floor, Hearing Room C, Columbus, Ohio 43215-3793.
- (5) As prior entries have indicated and Ms. Tandy has been informed, in Commission proceedings, the complainant has the

burden of proving the allegations set forth in the complaint. Thus, at the hearing it shall be Ms. Tandy's responsibility to appear and be prepared to present evidence in support of the complaint. Should Ms. Tandy fail to appear, the Attorney Examiner will recommend to the Commission that this case be dismissed.

It is, therefore,

ORDERED, That the hearing in this case be rescheduled to February 28, 2013, at 11:30 a.m., at the offices of the Commission, 180 East Broad Street, Columbus, Ohio in accordance with finding 4. It is, further,

ORDERED, That a copy of this entry be served upon Ms. Tandy, Dominion and its counsel, and all other interested persons of record.
