MOTION TO RESCHEDULE SETTLEMENT CONFERENCE

In accordance with Rules 4901-1-13 and 4901-1-12(A), Ohio Adm. Code, The East Ohio Gas Company d/b/a Dominion East Ohio (“DEO” or “the Company”) respectfully requests an Entry rescheduling the settlement conference for this case to Thursday, March 21, 2013, at 3:00 p.m. Good cause exists for granting this motion, which is explained below.

On January 16, 2013, the Complainants filed their complaint in this case against DEO. On February 5, 2013, DEO filed its answer in response to the complaint. By Entry dated February 20, 2013, the Attorney Examiner scheduled a settlement conference in this matter for March 21, 2013, at 10:00 a.m. Entry at 2.

Counsel for DEO, however, is representing the Company in a hearing for a separate matter at the same time, and so has a scheduling conflict. On February 21, 2013, counsel for DEO contacted the Complainants by phone to discuss rescheduling the settlement conference. Complainants had no objection to DEO requesting that the settlement conference be rescheduled, and agreed to reschedule to March 21, 2013, at 3:00 p.m. The Commission routinely grants

motions to reschedule where the parties agree. *See, e.g., In re the Complaint of Cincinnati Dental Care, v. Duke Energy Ohio, Inc.*, Entry (Aug. 17, 2012); *In re the Complaint of SUBS 4 U, LLC v. Duke Energy of Ohio, Inc.*, Case No. 12-1951-EL-CSS, Entry (Aug. 15, 2012).

For the foregoing reasons, DEO respectfully requests that the Commission grant the motion to reschedule the settlement conference to March 21, 2013, at 3:00 p.m.
