

Agents and employees of Duke Energy threatened to disconnect my electric service unless I accepted a transfer of charges established at 833 Rockdale, Cincinnati, Ohio, by Mildred Reese. Ms Reese established this account without my knowledge, consent, or authority and after misappropriating personal identification information she had received at the time I performed household maintenance and repair services for her.

I have completed and submitted a police report to the Cincinnati Police Department and an Identity Theft Affidavit to Duke Energy, who has refused to accept those statements. Duke Energy has further failed to produce a purported telephone conversation in which I supposedly accepted their transfer.



It is unlawful to threaten to disconnect utilities for the purpose of collecting a debt I did not contract in the first place.

Duke Energy has refused to produce any audible evidence of an alleged agreement on the part of Mr Demus either to open the account or assume responsibility for the acct.

We believe that Duke Energy is proceeding in this manner in both an unlawful and discriminatory manner in taking advantage of Mr Demus's current sight impairment and inability to protect his interest without the ability of counsel.


It is requested that the Public Utilities Commission of Ohio would issue an order to Duke Energy to cease all attempts and threats of disconnection of service at any account maintained by Mr Demus now and in the future on account of service provided at 833 Rockdale Avenue, Cincinnati, Ohio.
