Construction Notice

AEP Ohio submits the following.

4906-11-02 (B)

(1) Name of Project

The name of this project is the Wagenhals – West Canton 138kV Line Structure Replacement.

(2) Description of Project

Existing tower #51 will be replaced with a single pole double circuit davit arm dead end structure. This structure is being replaced due to structural loading issues. See Map A.

(3) Need of Project

Currently, there are two (2) circuits attached to the existing tower. AEP Ohio is proposing to remove one (1) span of one of the existing circuits, which causes the tower to fail due to the unbalanced tower loading. A single tubular structure will be installed in-place of the existing tower.

(4) Construction Schedule

Construction of this transmission line project is expected to begin early October 2013 and be completed by mid-November 2013.

(5) Estimated Cost

The cost of this project is estimated to be \$90,012.68.

(6) Right of Way Requirements and Structure Details

No additional right-of-way easements will be required for this project. One single pole davit arm structure will be installed within AEP Ohio's existing right of way to replace the existing tower #51.

(7) Map

The line is located in Stark County, approximately 4 miles northwest of Canton, OH. From Canton, OH, head South on Mckinley Ave SW toward 2nd St SW. Take the 1st right onto 2nd St SW. Take the 1st right onto Wells Ave SW. Turn left onto Tuscarawas St W. Take the 1st right onto Fulton Rd NW. Turn right onto Whipple Ave NW. Turn left on 38th St NW and arrive at structure 51 just north of AEP's West Canton Station.



(8) Properties

The construction of this project is within the Wagenhals – West Canton 138kV Line easement width. No other additional right-of-way rights are required.
