Dear Ms. McCauley:

On March 15, 2013, respective legal counsel on behalf of the Staff of the Public Utilities Commission of Ohio (Staff) and respondent, Mr. Burlen L. Collins (Mr. Collins), filed a Settlement Agreement in this proceeding. Upon further discussions, both Parties agree to modify the March 15, 2013 Settlement Agreement as follows:

- (1) The language in Section III(B) shall be deleted and replaced with: For settlement purposes only, Mr. Collins agrees to pay a civil forfeiture in the amount of \$500.00 to resolve the case; and
- (2) The language in Section III(C) shall be deleted and replaced with: Mr. Collins will pay the \$500.00 in ten consecutive monthly payments of \$50.00 commencing within thirty days of the Commission's order approving this Settlement Agreement. The payments shall be made payable to "Treasurer State of Ohio," and they shall be mailed to PUCO Fiscal, 180 E. Broad St., 4th floor, Columbus, OH 43215-3793. The case number (OH3267006087D) should appear on the face of each check.

All terms and conditions of the March 15, 2013 Settlement Agreement not specifically modified above shall remain in full force and effect. Counsel for Mr. Collins has reviewed this letter and concurs with the above modifications. Please contact me if you have any questions.
