On April 1, 2013, the Staff of the Public Utilities Commission of Ohio (Staff ) and the Office of the Ohio Consumers' Counsel (OCC) moved to continue the hearing in this proceeding in order to allow time to submit a possible stipulation. On April 3, 2013, the Attorney Examiner granted a motion to continue and set the hearing on this matter for April 11, 2013. On April 8, 2013, the Parties jointly submitted a Stipulation and Recommendation resolving the issues.
