## **ENTRY**

## The Commission finds:

- (1) On September 8, 2011, Stephen Gendler (Applicant) filed an application for certification as an eligible Ohio renewable energy resource generating facility.
- (2) On November 11, 2011, the Commission issued Certificate No. 11-SPV-MI-GATS-2876 to the Applicant certifying the facility as an eligible Ohio Renewable Energy Resource Generating Facility.
- (3) On May 1, 2013, the Applicant filed a notice that effective March 25, 2013, the Applicant's facility was registered under the Michigan Renewable Energy Certification System (MIRECS) and that the facility had been deactivated from PJM's Generation Attributes Tracking System (GATS) on April 30, 2013.
- (4) On May 2, 2013, Commission Staff filed its Findings and Recommendations on the Applicant's facility. In the Findings and Recommendations, Staff finds that the facility was previously registered with PJM's GATS but is now registered with the MIRECS. However, the Commission has not approved MIRECS and has previously denied certification to facilities intending to register with MIRECS. In In the Matter of the Application of Pine Tree Acres for Certification as an Eligible Ohio Renewable Energy Resource Generating Facility, Case No. 11-4171-EL-REN, the Commission denied the application of Pine Tree Acres for certification as an eligible Ohio renewable energy resource generating facility because Pine Tree Acres was registered with MIRECS and not with an attribute tracking system approved for use by the Commission. In the present case, Staff recommends that the certificate previously issued for the Applicant be cancelled effective March 25, 2013.

(5) Pursuant to Rule 4901:1-40-04(D)(2), Ohio Administrative Code (O.A.C.), an Applicant must be a registered member in good standing with GATS, MISO's renewable energy tracking system, or another tracking system approved for use by the Commission. MIRECS has not sought Commission approval as a credible tracking system. Accordingly, upon review of Staff's Findings and Recommendations, and Rule 4901:1-40-04(D)(2), O.A.C., the Commission finds that the Applicant's previously approved certificate be cancelled effective March 25, 2013.

It is, therefore,

ORDERED, That the Applicant's previously approved certificate as an eligible Ohio renewable energy resource generating facility be cancelled effective March 25, 2013, in accordance with finding (5). It is, further,

ORDERED, That a copy of this entry be served upon each party of record.
