4 ATTORNEY EXAMINER MCKENNEY: Good
5 morning. The Public Utilities Commission of Ohio
6 calls for hearing at this time and place Case No.
7 12-2888-TR-CVF, Being In the Matter of Spinners Steal
8 Games, Notice of Apparent Violation and Intent to
9 Assess Forfeiture.

10 and Spinners Steal Games have reached a settlement in
11 principle. We're just waiting to get the documents
12 drafted and get the signature on the document to get
13 the settlement before the Commission, so we don't
14 believe that there's ultimately going to need to be a
15 hearing, but if there is, we would like to continue
16 it out for the convenience of the Commission.

17 ATTORNEY EXAMINER MCKENNEY: You are in
18 agreement with that?

19 MR. RAKESTRAW: We would certainly agree
20 with the request. I think Mr. Turek and I have
21 worked on this for some time. The principal of
22 Spinners has been out of town for the winter. He
23 just got back and signed the affidavit. Mr. Turek is
24 adding some things to the affidavit, some items, and
25 then we're drafting a Settlement Agreement, which

1 we'll present to Mr. Turek -- actually, the
2 Commission is drafting the agreement. I don't see
3 anything in there that would prevent us from signing
4 it.

5 ATTORNEY EXAMINER MCKENNEY: Great. At
6 this time, we'll go ahead and grant the motion to
7 continue this case until further notice. Thank you.

8 MR. RAKESTRAW: Thank you, your Honor.
