



#### 4906-11-02 (B) (1): Name of the Project

## 4906-11-02 (B) (2) (a): Brief Description of Project

In the Allen Junction Substation Expansion Project, American Transmission Systems, Incorporated ("ATSI"), a FirstEnergy company, is proposing to expand a portion of the existing Allen Junction Substation fence to incorporate new bus work that is associated with the addition of a second transformer and breaker. A field assessment was conducted in the area of the proposed substation expansion to determine the presence of wetlands and/or any other ecologic features. The field assessment did not identify any ecologic features. The proposed Project is located in Sylvania Township, Lucas County, Ohio.

The general location of the proposed Project is shown in Exhibit 1, which is a partial copy of the United States Geologic Survey, Lucas County, Ohio; Lenawee and Monroe Counties, Michigan Quad, Map ID 41083-F7. The general layout of the proposed Project is shown in Exhibit 2. The existing Allen Junction Substation encompasses an approximately 587,143 square foot area. The southwestern end of the substation will be expanded by, approximately 25,000 square feet to accommodate the additional substation equipment.

## 4906-11-02 (B) (2) (b): Construction Notice Requirements

The proposed Project meets the requirements for a Construction Notice because the project is within the types of project defined by Item (8) and of the Application Requirement Matrix for Electric Power Transmission Lines in Appendix A of 4906-1-01 of the Ohio Administrative Code and the Interim Procedural Order issued in Case No. 12-1981-GE-BRO on September 4, 2012, which requires the filing of a Construction Notice. This items states:

(8) Constructing additions to existing electric power transmission substation where:
(a) There is a twenty percent or less expansion of the fenced area

The proposed Project includes expanding a small portion of the southwestern fence line approximately 116 feet to the south and 216 feet to the west of the existing fence as shown in Exhibit 2. This will expand the footprint of the substation by approximately 25,000 square feet. This represents an approximate 4% percent expansion of the substation.

#### <u>4906-11-02 (B) (3): Need for the Project</u>

The proposed Project is needed to incorporate new bus work that is associated with the addition of a second transformer and breaker. The new transformer, breaker and associated bus work are needed to address low voltages on the 138 kV system near Allen Junction, due to retirement of Units 2-4 at the Bayshore Generation Plant.

#### 4906-11-02 (B) (4): Construction Schedule

Construction on the proposed Project is proposed to begin as early as October 1, 2013. Construction on the proposed Project is expected to be completed by May 31, 2014.

## 4906-11-02 (B) (6): Operating Characteristics

The operating characteristics of the Allen Junction Transmission Substation will not be affected by the addition of a second transformer, breaker and associated bus work.

#### <u>4906-11-02 (B) (7): Area Map</u>

Exhibit No. 1 depicts the general location of the project site. This exhibit provides a partial copy of the United States Geologic Survey, Lucas County, Ohio; Lenawee and Monroe Counties, Michigan Quad, Map ID 41083-F7. To locate and view the project site from Columbus, Ohio, travel north on I-71 approximately 11 miles and take exit 119 to merge onto I-270 W toward Dayton for approximately 2.2 miles. Take exit 23 to merge onto US-23 N/N High St. toward Delaware and continue to follow US-23 N for approximately 67 miles. Continue onto OH-15 W for approximately 17 miles. Keep right at the fork and follow signs for 75 N/Ohio 15/Toledo and merge onto I-75 N for approximately 35 miles. Take exit 192 on the left to merge onto I-475 N/US-23 N toward Maumee/Ann Arbor and go 13 miles. Take exit 13 for US-20/Central Ave toward OH-13 and turn left onto OH-120 W/US-20 W/W Central Ave and go approximately 3.3 miles. Turn right onto Co Rd 41/Herr Rd go 1 mile then turn left onto Co Rd 41/Sylvania Ave and then take the first right onto Mitchaw Rd and go 2 miles. Turn left onto Co Rd 4/Sylvania-Metamora Rd and go 1 mile, then turn right onto Allen Rd and go approximately .5 miles. The project site will be on the east side of the road.

## 4906-11-02 (B) (8): Properties List

The Allen Junction Substation is owned by ATSI and located on The Toledo Edison Company ("Toledo Edison") property. The proposed expansion of Allen Junction Substation will be owned by ATSI. Toledo Edison and ATSI are both FirstEnergy companies, and no additional property rights are needed to construct the project.


