**JOINT MOTION FOR CONTINUANCE OF HEARING DATE AND SCHEDULE**

Pursuant to Ohio Adm. Code 4901-1-12 and 4901-1-13, the Village of Kirkersville and United Telephone Company of Ohio d/b/a CenturyLink (“CenturyLink”) respectfully move for a continuance of the testimony due date of June 3, 2013 and the hearing date of June 10, 2013 in this matter.

The Parties are presently in settlement discussions and would like to defer the testimony due date and hearing date until after they know whether the settlement discussions will be fruitful. CenturyLink made a settlement proposal to the Village of Kirkersville on May 21, 2013 and that proposal will be considered by the Village of Kirkersville at its next Village Council meeting on June 5, 2013. The Parties propose that new dates be set at the June 3, 2013 status hearing in this matter. The Parties are willing to waive the 120 day time period set forth in R.C. 4939.06(B) for resolving this complaint proceeding.

This extension is being sought in good faith and without any intention to cause undue

delay. This motion should be granted for good cause as set forth more fully in the accompanying memorandum in support.
