ENTRY

The attorney examiner finds:

- (1) Pursuant to Rule 4901:2-7-12, Ohio Administrative Code (O.A.C.), the Commission's Staff has served a notice of preliminary determination upon Saif S. Al (Respondent), alleging a violation of the Commission's transportation regulations.
- (2) On March 26, 2013, Respondent filed a request for an administrative hearing in the above-captioned case in accordance with Rule 4901:2-7-13, O.A.C.
- (3) By entry issued April 9, 2013, the attorney examiner scheduled the matter for a prehearing conference on April 29, 2013, pursuant to Rule 4901:2-7-16(B), O.A.C. Thereafter, at Respondent's request, the attorney examiner rescheduled the prehearing conference for May 7, 2013. The parties were unable to settle this matter during the prehearing conference.
- (4) Accordingly, the attorney examiner finds that a hearing should be scheduled for June 26, 2013, at 1:00 p.m., at the offices of the Commission, 180 East Broad Street, 11th floor, Hearing Room 11-A, Columbus, Ohio 43215-3793.
- (5) Rule 4901:2-7-14(A), O.A.C., provides that a respondent who has requested an administrative hearing and fails to participate in the hearing proceeding shall be in default. The rule additionally states that a respondent in default shall be deemed to have admitted the occurrence of the violation and waived all further right to contest liability to the state for the forfeiture described in the notice.
- (6) At the hearing, Staff must prove, by the preponderance of the evidence, that Respondent committed the alleged violation, pursuant to Rule 4901:2-7-20(A), O.A.C.

It is, therefore,

ORDERED, That the matter be scheduled for a hearing in accordance with Finding (4). It is, further,

ORDERED, That a copy of this entry be served upon all parties of record.
