ANSWER OF VERDE ENERGY USA OHIO, LLC

Verde Energy USA Ohio, LLC ("Verde" or "the Respondent"), by its attorneys, Vorys, Sater, Seymour and Pease LLP, hereby answers the May 22, 2013 formal complaint form (the "Complaint") of Anne L. Lauderdale ("Lauderdale" or "Complainant") as follows:

- 1. Verde operates as a competitive retail electric supplier in the state of Ohio pursuant to Certificate No. 12-489E(1) issued in Case No. 11-5886-EL-CRS.
 - 2. Verde admits that Complainant is a customer of the Respondent.
- 3. Verde denies that it began to supply electric service to Complainant without Complainant's consent. Verde has supplied electric service to Complainant since September 14, 2012 at Account No. _____ (REDACTED) in accordance with Complainant's telephone enrollment as a Verde customer on August 23, 2012. Please find submitted under seal as Exhibit A, a compact disc containing the audio of the third-party verification of Complainant's enrollment and a public version of Exhibit B, a transcription of Complainant's third-party verification.

- 4. Verde denies knowledge or information sufficient to form a belief as to the truth of the allegations contained in the Complaint regarding "Star Energy," "IGS Energy," or "First Energy Solutions."
- 5. With respect to Complainant's belief that she "has been slammed," Verde states that the allegations regarding Complainant's beliefs are allegations not requiring an admission or denial. To the extent that an answer is deemed required, Verde denies knowledge or information sufficient to form a belief regarding those allegations.
- 6. With respect to Complainant's demand that she "be reimbursed our 506.00" Verde states that the allegations regarding Complainant's demands are allegations not requiring an admission or denial. To the extent that an answer is required of Verde, Verde admits that the bill in the amount of \$506.55 provided to Complainant was correct based on the utility meter readings that were supplied to Verde from Dayton Power and Light Company pursuant to Account No. _____ (REDACTED) for the period 1/14/13 2/1/13.
- 7. With respect to Complainant's request that Verde "consent and validate fees and charges," Verde admits that it provides proof of Complainant's consent to its services in Exhibits A and B and verifies Complainant's charges in accordance with the meter readings for Account No. (REDACTED).
- 8. Verde reserves the right to amend this Answer to assert any additional defenses after further discovery and investigation.

WHEREFORE, having fully answered the allegations set forth in the Complaint, Verde Energy USA Ohio, LLC respectfully requests that the Public Utilities Commission of Ohio enter judgment:

(a) dismissing the Complaint in its entirety, with prejudice; and

(b) granting such other and further relief as the Commission may deem proper.
