

## **MEMORANDUM IN SUPPORT**


Pursuant to Rules 4901-1-12(C) and 4901-1-13 of the Ohio Administrative Code, Northeast Ohio Natural Gas Corporation ("Northeast") and Orwell Natural Gas Company ("Orwell") (collectively, the "Companies"), by and through undersigned counsel, respectfully request the Public Utilities Commission of Ohio ("Commission") grant a thirty (30) day extension of the procedural schedule in the above captioned cases. The Companies, the Ohio Consumers' Counsel and the PUCO Staff have been negotiating, in good faith, toward a potential resolution and believe this extension may facilitate a resolution. Attorneys for the PUCO Staff and the OCC have indicated their support for this motion. Accordingly, the Companies request the prior schedule be modified as follows:

1. Publication of Hearing: between July 8, 2013 and July 23, 2013
2. Companies' Direct Testimony: July 22, 2013
3. Other Parties' Direct Testimony: July 31, 2013
4. Hearing: August 7, 2013

Pursuant to O.A.C. 4901-1-12(C), the Companies request an expedited ruling from the Commission. The Companies certify that no party objects to the issuance of such a ruling, and therefore, requests the issuance of an immediate ruling.

Wherefore, the Companies respectfully request that the Commission grant the Companies a thirty (30) day extension of the procedural schedule.
