## CORRECTION TO THE ANNUAL EFC REVIEW

The Staff docketed its "Annual EFC Review" on February 7, 2000. Contained in the written report was a recommendation for the Commission to adopt the new EFC Rates calculated by the Staff. However, it was found that an incorrect number of kilowatthours was used in computing the Quarto Adjustment. The Staff obtained the correct number of kilowatthours from FirstEnergy and calculated the new EFC Rate for The Cleveland Electric Illuminating Company to be 1.3394 ¢/kWh and 1.3300 ¢/kWh for The Toledo Edison Company. The development of the proposed EFC Rates is shown below:

#### The Cleveland Electric Illuminating Company

Quarto Adjustment (1.3918 - 0.0689) = 1.3229

EFC = (FC Base x [1+GDP]) + Fixed Component

EFC =  $((1.3229 \times 0.85) \times [1 + 0.0147]) + 0.1984$ 

EFC = 1.3394 ¢/kWh

#### The Toledo Edison Company

Quarto Adjustment (1.3717 - 0.0715) = 1.3002

EFC = (FC Base x [1+GDP]) + Fixed Component

EFC =  $((1.3002 \times 0.85) \times [1 + 0.0147]) + 0.1950$ 

 $EFC = 1.3164 \, \epsilon/kWh$ 

Deferred Revenue from September 1998 = 0.0136

 $EFC = 1.3300 \, \epsilon/kWh$ 

Note: The deferred revenue from September 1998 of 0.0136 ¢/kWh was approved in Finding and Order 97-107-EL-EFC.

The impact on residential customers who use an average of 750 kWh per month will see a decrease in their electric bills of approximately 39¢ for CEI and 31¢ for TE. The Staff recommends that these EFC Rates become effective with bills rendered on March 1, 2000.
