**MOTION OF THE APPLICANT,  
THE DAYTON POWER AND LIGHT COMPANY,  
TO EXTEND DEADLINE FOR FILING OBJECTIONS**

---

Pursuant to Rules 4901-1-12 and 4901-1-13 of the Ohio Administrative Code, the Dayton Power and Light Company (“DP&L”) moves the Public Utilities Commission of Ohio (“Commission”) for an order extending the deadline for parties to file objections for an additional three weeks, to August 8, 2013.


DP&L moved to modify the scheduling order on June 14, 2013 and by Attorney Examiner’s Entry granting DP&L’s motion that same day, the deadline for parties to file objections was set for July 18, 2013. DP&L respectfully moves for a three week delay, so that the deadline for Intervening Parties to file objections would now be set for August 8, 2013. The parties continue to be engaged in productive settlement discussions, and are still making progress on exploring opportunities to resolve issues in this case by way of settlement that would dispense with the need for a hearing. In light of these continuing discussions, good cause exists to extend the deadline for filing objections for three weeks. All other aspects of the schedule would remain unchanged.

In light of the fast-approaching current deadline for filing objections, DP&L also requests an expedited ruling in this matter pursuant to Ohio Adm. Code 4901-1-12(C). Commission Staff

and all parties have indicated they do not oppose this three week extension of the deadline, nor do they oppose an expedited ruling on this motion.

For the foregoing reasons, good cause exists to modify the procedural schedule in this case as set forth above in order to allow the parties to focus on continuing settlement discussions.


