STATEMENT REGARDING RESOLUTION OF ISSUES

The June 12, 2013 Entry in this case ordered Vectren Energy Delivery of Ohio, Inc. (“VEDO”) to file by today a statement informing the Commission whether the issues raised in the comments have been resolved. On July 26, the Commission’s Staff and the Office of the Ohio Consumers’ Counsel (“OCC”) filed comments concerning VEDO’s application. Staff’s Comments recommended approval of the application, and no issues need be resolved between Staff and VEDO. OCC raised four issues, and at this time, those issues have not been resolved.

VEDO would note that the parties are in the process of discussing a proposed Stipulation and Recommendation to resolve this case. Thus, it is unclear at this time whether and to what extent a hearing on the merits will be required.
