STATUS UPDATE

On August 22, 2013 the Attorney Examiner issued an Entry granting the Dayton Power and Light Company's motion to extend the deadline for filing objections and suspending the procedural schedule. Further, the Attorney Examiner directed that DP&L file a status update on September 6, 2013. By way of update, the parties have continued to engage in settlement negotiations over the past several weeks, and these negotiations have continued to yield positive results with many of the intervening parties. Several parties have already affirmatively indicated a willingness to sign a draft stipulation which has been prepared and circulated. While not all parties have indicated a willingness to sign either publically or confidentially, DP&L will be circulating what it believes to be a close to final version of the stipulation shortly, asking for final commitment of signatures. That said, DP&L wishes to continue working toward settlement over the next few weeks with the parties who still have not indicated a willingness to sign, in a final effort to attempt to secure unanimous agreement. For that reason, DP&L respectfully proposes that the Attorney Examiner call and continue the hearing currently scheduled for September 26, 2013, but reschedule the hearing in this matter to occur October 17, 2013 with the following procedural schedule:

Objection Deadline

September 20, 2013

DP&L and Intervenor testimony September 27, 2013

Staff Testimony October 4, 2013

Hearing October 17, 2013

For the foregoing reasons, good cause exists to modify the procedural schedule in this case as set forth above in order to allow the parties to focus on continuing settlement discussions.
