MOTION OF TSC COMMUNICATIONS, INC.
FOR EXTENSION OF TIME IN WHICH TO ACTIVATE
TELEPHONE NUMBERING RESOURCES

TSC Communications, Inc. ("TSCC") respectfully requests that the Public Utilities Commission of Ohio ("Commission") grant TSCC an extension of time in which to activate one thousands-block of telephone numbers, as well as a code, assigned to it in the Findlay rate center. The number block, 567-250-5XXX, and the code 567-250, were assigned on November 2, 2012 and have exceeded the due date to submit the confirmation of "in service" to Neustar. Reclamation of the numbers would cause TSCC and its customers significant hardship. TSCC requests an extension of ninety (90) days in which to place the affected telephone numbering resources into service.

TSCC has encountered numerous delays in turning up the service while working with AT&T, the incumbent local exchange carrier. The escalation process with AT&T has not resolved the rejected orders, even though TSCC has provided the information correctly. TSCC continues to work with AT&T, as it remains dependent on the AT&T CLEC team to resolve the ordering delays that TSCC has encountered. TSCC requests that it be granted a ninety (90) day extension in which to place the affected telephone numbering resources into service.

If this block and code are reclaimed, it would further delay the time to turn up service and would adversely impact the business needs of TSCC. An extension of time in which to active

the numbering resources is appropriate, given the short duration of the requested extension and the expectation that the numbering resources have an immediate use.

Given the short duration of the requested extension and the hardship imposed on the company of being forced to return 567-250-5XXX thousand-block, TSCC respectfully requests that its Motion be granted.
