Dear Secretary,

The above captioned licensee ("Petitioner"), hereby petitions the Commission to amend its current license to reflect the change in primary corporate entity name from "PJM Wholesale Brokers, LLC" to "US Grid Energy, LLC."

The Petitioner has amended its charter documentation in its state of formation, Delaware, as well as with the Corporations Division, and provides such documentation herein. Moreover, the Petitioner's Surety has amended each respective bond to reflect the change in entity name.

No other change in ownership, managerial, technical, or financial capacity for which the Commission originally relied upon to grant licensure has taken place and this is simply a corporate name change with no change to the original federal tax identification number issued. The name change was a result PJM Interconnections concern as well as both Delaware and Pennsylvania's concern over possible confusion to customers that PJM Wholesale Brokers, LLC was somehow related to PJM Interconnection. In efforts to address any possible concern the Public Service Commission's had, PJM Wholesale Brokers, LLC agreed to change the corporate name and has done so in all State's in order to achieve uniformity and brand awareness. As a result both Delaware and Pennsylvania approved licensing. This letter is to respectfully request simply that the original entity name reflect the change from "PJM Wholesale Broker, LLC" to "US Grid Energy, LLC."


