FINDING AND ORDER

The Commission finds:

- (1) Glenwood Energy of Oxford, Inc. (Glenwood) is a public utility as defined in Section 4905.02, Revised Code, and, as such, is subject to the jurisdiction of this Commission.
- (2) Pursuant to the stipulation approved by the Commission on September 19, 2007, in In the Matter of the Complaint and Appeal of Oxford Natural Gas Company from Ordinance No. 2896 Passed by Council of the City of Oxford on February 7, 2006, Case No. 06-350-GA-CMR, et al., Glenwood was authorized to establish an uncollectible expense (UEX) rider pursuant to the terms set forth in the Finding and Order issued on December 17, 2003, in In the Matter of the Joint Application of Columbia Gas of Ohio, Inc., et al., for Approval of an Adjustment Mechanism to Recover Uncollectible Expenses, Case No. 03-1127-GA-UNC.
- (3) By Entry issued September 30, 2009, in *In the Matter of the Application of Glenwood Energy of Oxford, Inc. for Approval of its Initial Uncollectible Expense Rider Rate,* Case No. 09-439-GA-UEX, the Commission approved Glenwood's first application for a UEX rider.
- (4) Glenwood's current UEX rider rate of \$0.26 per thousand cubic feet (Mcf) was approved by Finding and Order dated September 22, 2010, in In the Matter of the Application of Glenwood Energy of Oxford, Inc. for Approval of an Adjustment to Its Uncollectible Expense Rider Rate, Case No. 10-899-GA-UEX.

Glenwood was previously known as the Oxford Natural Gas Company. On October 10, 2007, in In the Matter of the Application of Glenwood Energy of Oxford, Inc. for Commission Approval of the Purchase of Property, Plant or Business of Oxford Natural Gas Company, Case No. 07-1025-GA-ATR, the Commission granted Glenwood approval to purchase the assets of the Oxford Natural Gas Company.

(5) On September 5, 2013, Glenwood filed the instant application to decrease its existing UEX rider rate to \$0.0459 per Mcf effective with the September 30, 2013, billings. Glenwood submits that the proposed UEX rider rate captures an overcollection of \$39,609 as of March 31, 2013, and projected write-offs for the period July 1, 2013 to December 31, 2013, in the amount of \$55,687.

- (6) On September 11, 2013, Staff filed its report on Glenwood's application, recommending approval of the proposed UEX rider rate of \$0.0459 per Mcf.
- (7) The Commission reviewed the application and Staff's recommendation, and finds that the proposed decrease to Glenwood's UEX rider is reasonable and in the public interest, and should be approved.

It is, therefore,

ORDERED, That Glenwood's application be approved and Glenwood be authorized to decrease the rate for its UEX rider to \$0.0459 per Mcf. It is, further,

ORDERED, That Glenwood is authorized to file four complete copies of tariffs in final form consistent with this Finding and Order. Glenwood shall file one copy in this case docket and one copy in its TRF docket (or make such filing electronically as directed in Case No. 06-900-AU-WVR). The remaining two copies shall be designated for distribution to the Utilities Rates and Tariffs Division of the Commission's Utilities Department. It is, further,

ORDERED, That the effective date of the new tariffs shall be a date not earlier than the date upon which final tariffs are filed with the Commission. It is, further,

ORDERED, That nothing in this Finding and Order shall be binding upon this Commission in any further proceeding or investigation involving the justness or reasonableness of any rate, charge, rule, or regulation. It is, further,

ORDERED, That a copy of this entry be served upon Glenwood and all interested persons of record.
