Pursuant to the second ordering paragraph of the September 18, 2013 Finding and Order issued earlier today, I am filing on behalf of Glenwood Energy of Oxford, Inc. a final copy of Second Revised Sheet 19.1 which cancels First Revised Sheet 19.1 contained in the Glenwood Energy of Oxford, Inc. Tariff, P.U.C.O. No. 1.

62.1 <u>Uncollectible Expense Rider</u>. In addition to the above rates, a charge of \$0.0459 per Mcf will be applied to all gas consumed pursuant to this rate schedule to recover the cost associated with uncollectible accounts of those Customers subject to Uncollectible Expense Riders. The Company will file an application with the Public Utilities Commission of Ohio requesting approval to change this charge if the Company determines that the annual uncollectible expense has increased or decreased by more than ten percent compared to the uncollectible expense experience during the annual period upon which the current charge is based.
