Utilities Commission of Ohio has called for
hearing at this time and place Case No.
13-1138-TR-CVF being in the matter of Robbie D.
Wood, Inc., notice of apparent violation and
intent to assess forfeiture.

My name is Sarah Parrot. I'm the
Attorney Examiner assigned by the Commission to
hear this case today.

180 East Broad Street, 6th Floor, Columbus, Ohio.

HEARING EXAMINER PARROT: Thank you
very much. At this time I will note for the
record that no one is present in the hearing
room today on behalf of the Respondent. I will

1 note that pursuant to Attorney Examiner entry of
2 July 11, 2013, this case was set for hearing at
3 this time and place today, and a copy of that
4 entry was served upon the Respondent on that
5 same date, July 11, 2013. Mr. Margard?

6 MR. MARGARD: Thank you, Your Honor.
7 For the record, I will note that we did have a
8 conversation with Respondent this morning. They
9 indicated that they would not be in attendance
10 at today's hearing and that they would not be
11 further prosecuting their application for
12 hearing in this case. Consequently, the Staff
13 would respectfully move that default judgment be
14 entered in this case and that the Respondent be
15 assessed the amount of \$3,840.

16 HEARING EXAMINER PARROT: All right.
17 The motion will be taken under advisement. At
18 this point, I think, do you have exhibits with
19 you, Mr. Margard?

20 MR. MARGARD: I do, Your Honor.

21 HEARING EXAMINER PARROT: Please go
22 ahead and mark those and move them into the
23 record.

24 MR. MARGARD: Your Honor, I have five
25 exhibits for purposes of the record this

1 morning. The first, and marked Staff Exhibit
2 No. 1, is a copy of the Inspection Report in
3 this case dated February 21st, 2013.

4 The second, marked Staff Exhibit No.
5 2, is the Forfeiture Assessment Matrix by which
6 the calculation was determined in this case.

7 Staff Exhibit No. 3 is a copy of the
8 Civil Forfeiture Violations Chart, Nature and
9 Gravity Points further explaining the matrix.

10 Staff Exhibit No. 4 is a list of the
11 history of violations with this Respondent.
12 Violations are a significant contributing factor
13 to the amount of the assessment in this case.

14 Staff Exhibit No. 5 are copies of the
15 Notice of Apparent Violation and Notice of
16 Preliminary Determination that were properly and
17 timely served on the Respondent in this case.

18 HEARING EXAMINER PARROT: All right.
19 The exhibits shall be so marked.
