**REPLY IN SUPPORT OF MOTION FOR CLARIFICATION  
BY VECTREN ENERGY DELIVERY OF OHIO, INC.**

In accordance with Ohio Adm. Code 4901-1-12(B)(2), Vectren Energy Delivery of Ohio, Inc. (“VEDO”) submits its reply in support of its September 4, 2013 Motion for Clarification. In its Motion for Clarification, VEDO requested that the Commission clarify two matters: (1) whether VEDO is authorized to disconnect Ms. Toliver’s utility service if necessary and otherwise appropriate; and (2) given that Ms. Toliver is apparently pursuing participation in the PIPP program, what payment should be required of her in order to participate. (VEDO Motion for Clarification at 2.)

On September 18, 2013, Ms. Toliver filed a memorandum contra VEDO’s motion, but rather than offer any reason to deny it, she simply rehashes many of the same arguments on the merits of the underlying complaint that the Commission has already considered and rejected. Because these arguments are irrelevant to VEDO’s motion, there is no reason to respond to them here. VEDO would again respectfully request that the Commission grant its motion for the reasons stated therein.
