## **ENTRY**

The attorney examiner finds:

- (1) Ohio Power Company (AEP Ohio) is a public utility as defined in Section 4905.02, Revised Code, and, as such, is subject to the jurisdiction of this Commission.
- (2) On June 29, 2012, AEP Ohio filed an application to update its Reliability Targets, Customer Average Interruption Duration Index, and System Average Interruption Frequency Index in accordance with Rule 4901:1-10-10, Ohio Administrative Code (O.A.C.).
- (3) By entry issued October 29, 2012, the attorney examiner scheduled a technical conference and established the following comment schedule, in accordance with Rule 4901:1-10-10(B)(6), O.A.C.:
  - (a) January 4, 2013 Deadline for the filing of comments on the application by any interested person.
  - (b) January 14, 2013 Deadline for the filing of comments on the application by Staff.
  - (c) January 22, 2013 Deadline for the filing of reply comments.
- (4) By entry issued September 19, 2013, the attorney examiner scheduled a prehearing conference in accordance with Rule 4901:1-10-10(B)(6)(e), O.A.C., for October 17, 2013.
- (5) On September 26, 2013, the Ohio Consumers' Counsel (OCC) filed a motion to modify the procedural schedule. In support of its motion, OCC explains that counsel for OCC is unavailable on October 17, 2013, and requests that the

prehearing conference be rescheduled to the following week. OCC provides that counsel for Staff and AEP Ohio have indicated that they do not oppose rescheduling the prehearing conference.

(6) The attorney examiner finds that OCC's motion is reasonable and should be granted. Accordingly, the prehearing conference should be rescheduled to October 23, 2013, at 9:30 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-C, Columbus, Ohio 43215-3793. Parties should be prepared to discuss issues raised within the comments and identify availability for tentative evidentiary hearing dates.

It is, therefore,

ORDERED, That the prehearing conference be rescheduled to October 23, 2013, at 9:30 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room 11-C, Columbus, Ohio 43215-3793. It is, further,

ORDERED, That a copy of this entry be served upon all interested persons and parties of record.
