Code § 4901-1-24(D) and the Commission's Entry in the above matter dated June 27, 2013, files this Motion for Protective Order to preserve the confidential and proprietary nature of certain of the information to be filed with the Commission. The basis for this Motion is set forth in the accompanying Memorandum in Support.

The Company is contemporaneously filing with the Commission its FCC Form 481. Confidential treatment is sought for the "Rate of Return Carrier Additional Information" section contained within the Federal Communications Commission's Form 481,¹ which consists of the Company's financial reports.

In conformance with Rule 4901-1-24(D) of the Ohio Administrative Code, Sycamore has filed only such information redacted as is essential to prevent disclosure of confidential and



**MEMORANDUM IN SUPPORT OF
MOTION FOR PROTECTIVE ORDER**

Sycamore Telephone Company (“Sycamore” or “Company”) is concurrently filing FCC Form 481, Carrier Annual Reporting Data Collection Form (“Form 481”), which includes financial statements and other proprietary financial information required in “Rate of Return Carrier Additional Information” section¹ (the “Confidential Information”). Because the Company considers this information to be confidential this section has been filed under seal as required by Ohio Adm. Code 4901-1-24(D).²

Section 4905.07, Revised Code, provides that all facts and information in the possession of the Commission shall be public, except as provided in Revised Code Section 149.43, and as consistent with the purposes of Title 49 of the Revised Code. Section 149.43 specifies that the term “public records” excludes information which, under state or federal law, may not be released. The Ohio Supreme Court has clarified that the “state or federal law” exemption is intended to cover trade secrets.³

Similarly, Rule 4901-1-24, O.A.C., allows the Commission to issue an order to protect the confidentiality of information contained in a filed document, “to the extent that state or federal law prohibits release of the information, including where the information is deemed ... to constitute a trade secret under Ohio law, and where non-disclosure of the information is not inconsistent with the purposes of Title 49 of the Revised Code.”

Ohio law defines a trade secret as “information . . . that satisfies both of the following: (1) It derives independent economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use; [or] (2) It is the subject of efforts that are reasonable under the circumstances to maintain its secrecy.” Revised Code Section 1333.61(D).

The Ohio Supreme Court has adopted six factors to be used in determining whether a trade secret claim meets the statutory definition:

- 1) The extent to which the information is known outside the business;
- 2) The extent to which it is known to those inside the business, i.e., by the employees;
- 3) The precautions taken by the holder of the trade secret to guard the secrecy of the information;
- 4) The savings effected and the value to the holder in having the information as against competitors;
- 5) The amount of effort or money expended in obtaining and developing the information; and
- 6) The amount of time and expense it would take for others to acquire and duplicate the information.⁴

The financial results of Sycamore for which confidential treatment is sought meets each of these tests. The Company is a small, privately held rural local exchange company that has

taken precautions to guard the secrecy of its financial results, including the Confidential Information, by limiting its dissemination. The Confidential Information is not known outside of Sycamore and is known within the Company only to senior managers and a limited number of employees with a particular need to know. Sycamore has expended a significant amount of time and money in developing the Confidential Information. The Confidential Information cannot be replicated by any other means.

The Confidential Information constitutes trade secrets as defined in Revised Code §1333.61(D). The information (1) derives economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use, and (2) is the subject of efforts that are reasonable under the circumstances to maintain its secrecy.


Confidential Information includes detail about Sycamore's finances that would be of significant interest to its competitors. Given the competitive environment of today's telecommunications industry, public disclosure of such competitively sensitive and confidential information would be greatly harmful to Sycamore give its competitors a competitive advantage through disclosure of information not otherwise made publicly available and adversely affect Sycamore's ability both to conduct business with other carriers and compete against them.

The protection of trade secret information from public disclosure is consistent with the purposes of Title 49, because the Commission and its Staff have access to the Confidential Information. Granting protection of the Confidential Information requested herein will not impair the Commission's regulatory responsibilities.

Confidential treatment of the Confidential Information contained within FCC Form 481 is, therefore, both appropriate and required by Ohio law. For the foregoing reasons, Sycamore Telephone Company prays this Motion for Protective Order be granted.
