In order to comply with the stipulated conditions and commitments pertaining to selected access roads to be constructed after a first pre-construction conference, specifically Condition No.11, in the Stipulation filed on October 28, 2013 and submitted at the evidentiary hearing on October 30, 2013, we are providing this letter describing the status of the Interconnection Service Agreement with PJM.

As of this date we have been informed that the ISA, ICSA and the Facilities Study have been submitted to PJM's legal department for final review prior to submittal to us for our comments and eventual execution.

According to PJM's regulations we have 60 days to review the documents prior to execution. We anticipate executing them prior to the 60 day window expiring, pending negotiations with PJM and AEP on certain terms and conditions.
