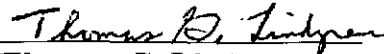
MOTION FOR A PROTECTIVE ORDER

MEMORANDUM IN SUPPORT

Staff requests that the Commission keep both the Report of the Commission's Consultant Regarding Duke Energy Ohio's November 2013 Standard Service Offer Auction and the Notification of CBP Auction Results confidential and that they not be publicly released. 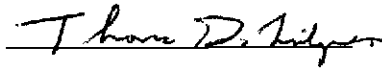
