## **ENTRY**

The attorney examiner finds:

- (1) On December 12, 2012, the Commission initiated an investigation into the health, strength, and vitality of Ohio's retail electric service market. The investigation was intended to establish actions that the Commission can take to enhance the health, strength, and vitality of the market. In its entry initiating the investigation, the Commission presented a series of questions to stakeholders regarding market design and corporate separation. Stakeholders provided comments and reply comments to the questions presented by the Commission.
- (2) On May 29, 2013, the Commission established a series of stakeholder collaboration workshops for the purpose of continuing the investigation into the health, strength, and vitality of the market. The workshop schedule included a workshop for December 12, 2013. To facilitate discussion in the workshop, the attorney examiner finds that the December 12, 2013, workshop should be rescheduled for December 11, 2013. Accordingly, the workshop will be held on December 11, 2013, at 10:00 a.m., at the offices of the Commission, 180 East Broad Street, 11th Floor, Hearing Room B, Columbus, Ohio 43215.
- (3) The Commission notes that the December 11, 2013, workshop will be in en banc format. This means that during the course of the workshop there will be panels of presenters on different subjects affecting the health, strength, and vitality of Ohio's retail electric market. The subjects that will be covered include a market overview, consumer education, customer enrollment options, contract portability, purchase of receivables, bill formatting, and electronic data interchange.
