This filing is being made on 15 days' notice under the Federal Communications Commission's streamlined filing procedures and proposes to increase the switched access direct-trunked transport (fixed) and special access channel mileage termination rates for OptiPoint services. The proposed rate adjustments are necessitated by the discovery of an error in the costing methodology employed by Sprint LTC in the development of the interoffice rates filed for OptiPoint services under Transmittal Nos. 78 and 99, dated March 19, 1999 and January 21, 2000, respectively.

It should be noted that there are seven OptiPoint interoffice facilities currently in service, affecting five customers, and Sprint LTC has advised each customer of the impact of this filing. The adjusted rates will be implemented on a going forward basis only, and customers will not be back billed for the difference between

the current and proposed rates. Additionally, as provided in Section 7.4.15(B), customers may discontinue OptiPoint service, without penalty, if the monthly recurring rates increase by more than 10% over current levels.

Description and justification material is provided for this filing, however, pursuant to Section 61.49(f)(3) of the Commission's rules, supporting cost information is not required since OptiPoint is a new service not yet included in Sprint LTC's price cap indices.

The original transmittal letter, along with FCC Form 159 and filing fees in the amount of \$630, is concurrently being delivered via Federal Express to the Wholesale Lockbox Shift Supervisor - Mellon Bank, pursuant to Section 61.32(b) of the Commission's Rules. Acknowledgment and date of receipt of this filing by the Mellon Bank is requested. A duplicate copy of the letter of transmittal is provided for this purpose.
