**NOTICE OF WITHDRAWAL OF REQUEST TO SHIFT WESTERN CONSTRUCTION  
STAGING AREA**

On November 21, 2103, an Entry issued in this matter setting a hearing on three proposed changes in Buckeye Wind LLC's ("Buckeye Wind") application to amend the certificate issued in Case No. 08-666-EL-BGN. The proposed changes subject to a hearing are: (1) the movement of one staging area 1.3 miles west; (2) shifting the project substation by 1,000 feet; and (3) the addition of a new access road. After review, Buckeye Wind has elected to not relocate the western construction staging area 1.3 miles west, and hereby gives notice that it withdraws its request to amend the certificate as to the relocation of the western construction staging area. The remainder of Buckeye Wind's application to amend its certificate stands as submitted.
