This filing is being made on 15 days' notice under the Federal Communications Commission's streamlined filing procedures and proposes to add monthly rates and nonrecurring charges in Section 8.3.5 for the provision of Frame Relay Service in the Indiana and Midwest jurisdictions. The Midwest jurisdiction includes customers in the states of Kansas, Minnesota, Missouri, Nebraska, Texas and Wyoming.

In addition, Sprint LTC proposes to expand its' DSL offering in Section 8.5.3 to include the Tallahassee wire centers (excluding TLHSFLXEDS0 and TLHSFLXGDS0). It should be noted that the existing DSL rates for Florida, originally filed under Transmittal No. 91 dated October 5, 1999, will apply to customers served by these wire centers.
