MEMORANDUM IN SUPPORT

Early Bird Power LLC ("EarlyBird") respectfully requests that the effectiveness of its Competitive Retail Natural Gas Aggregator/Broker Certificate, Number 11-231G(1), be extended until such time as the current certificate is renewed and/or a new certificate is granted. Due to an administrative oversight, EarlyBird delayed the filing of its application for renewal of its certificate, rather than November 22, 2013, as Ohio Administrative Code ("O.A.C.") Rule 4901:1-27-09(A) would otherwise require.
