MS. JOHNSON: My name is Katie Johnson. I'm with the Office of the Ohio Attorney General, Mike DeWine, in the Public Utilities Commission Section. We are located at 180 East Broad Street, Columbus, Ohio, 43215.

9 Rule 4901: 2-7-14, Section E, which provides that a
10 Respondent who requests an administrative hearing and
11 fails to appear shall be in default, shall be deemed
12 to have admitted the occurrence of the violation, and
13 waived all further right to contest liability for the
14 proposed forfeiture.

15 At this time I would like to mark several
16 exhibits for the record.

17 The first is Staff Exhibit 1A and 1B. It
18 is the Notice of Preliminary Determination in the
19 case that was issued to Jeremy Rowe.

20 And Staff Exhibit 2 is the Driver/Vehicle
21 examination report that was issued to Jeremy Rowe.

22 At this time I'd like to move these
23 documents into evidence.

24 THE ATTORNEY EXAMINER: Very good. I
