**MEMORANDUM IN SUPPORT OF THE UNOPPOSED MOTION
OF THE DAYTON POWER AND LIGHT COMPANY
TO CONTINUE THE EVIDENTIARY HEARING; EXPEDITED RULING REQUESTED**

On December 21, 2012, The Dayton Power and Light Company filed its Application for Authority to Recover Certain Storm-Related Restoration Costs. The Office of the Ohio Consumers' Counsel and The Kroger Company have intervened in this matter. The hearing in this case is currently set to start on February 11, 2014. Dec. 18, 2013, Entry on Rehearing, ¶7.

The parties are progressing in their settlement negotiations, and an extension of the hearing date would permit the parties to continue their settlement negotiations. DP&L thus asks the Commission for a one-week extension of the hearing date.
